ORDER



Admission Supervisory Committee, [for short, the Committee], by Order referred to as 1st paper above, permitted the Private Nursing College Managements Association of Kerala [for short, the PNCMAK] representing 49 Self-financing Nursing Colleges to publish the Notification inviting online applications from the aspirants of B.Sc. (Nursing), P.B.B.Sc. (Nursing)

& M.Sc. (Nursing) courses for the academic year 2026-27 subject to conditions prescribed therein.

2. Subsequently, the President of the Association of the Managements of Christian Self Financing Nursing Colleges of Kerala [for short, AMCSFNCK], by communication referred to as 2nd paper above, has submitted representation along with the draft prospectus before the Committee for approval.
3. On preliminary verification of the draft prospectus and the supporting documents, ASC found that action relating to the issuance of affiliation orders as also seat matrix was pending with the INC, KNMC, KUHS and the Government and that the request of the Association could be considered only after the issuance of those orders.
4. In the normal course, the admission process would commence from the date of publication of the notification inviting applications from the candidates. Publication of notification inviting applications and all subsequent steps for finalising the rank list and admitting the candidates are to be carried out in accordance with the schedule of admissions which is an integral part of the prospectus.

5. The unfortunate fact is that, the admission process, as stated above, is getting delayed due to the delay on the part of INC, KNMC and KUHS in issuing the requisite orders. No doubt, the candidates are the victims of such inordinate delay. Not only the opportunity due to the candidates to apply for the course on-time is denied but the legitimate interest of the colleges that are functioning within this State is also affected by the delay in commencing the admission process. Representatives of the Association would point out that some 'agents' who are interested in making money by offering admissions to the candidates in educational institutions outside this State are taking advantage of the present situation caused by the delay in starting the admission process in the Nursing Colleges in Keralam.
6. Committee thinks that there is substance in the apprehension entertained by the members of the Management Association and, therefore, immediate intervention by the ASC is necessary to safeguard the legitimate interest of the candidates and their parents on the one hand and the Managements running the college, on the other.
7. In the above facts and circumstances, it is only just and proper that the request made by the Association in its representation is granted subject to

such conditions that would protect the rights of the students community and the college authorities. Hence, ASC hereby order that pending approval of the draft prospectus, the Association representing the member colleges is permitted to invite applications from the candidates who aspire to get admission to B.Sc. (N), PB. B.Sc. (N) & M.Sc. (N) Courses 2026-27 by publishing Notification in the newspapers, website of the Association and the notice board of all the member colleges. Permission, as granted above, is subject to the following terms and conditions.

8. a) This invitation is published pending finalisation of the draft prospectus with the approval of the Admission Supervisory Committee.
- b) Applications will be processed, rank list of eligible and qualified candidates will be prepared and all further steps for admitting the qualified and eligible candidates will be taken in accordance with the provisions in the approved prospectus and the schedule of admissions which is an integral part of the prospectus.
- c) Notification inviting applications shall be published on or before 25th June 2026.
- d) Applications shall be submitted online.
- e) The last date for closing of online applications will be 25th July 2026.

9. Conditions, stated above, shall be incorporated in the Notification inviting applications for admission to the Nursing Courses.
